Aquatic Invasive Species (AIS) Technician Intern (Seasonal)

The TKPOA AIS Technician Intern is responsible for assisting the AIS Management Coordinator and the AIS Technicians with day-to-day activities that support the overall AIS Program goals. This will include fragment control, assisting with the field-based projects, collecting field data, and maintaining databases. Complete duties and support the TKPOA AIS Program as required in accordance with the TKPOA Waste Discharge Requirements. Conduct fragment control to reduce the amount of plant fragments from entering Lake Tahoe. Conduct the pre-sampling calibration of all equipment. Assist with project-specific water quality sampling and monitoring. Assist with macrophyte surveys and nutrient/sediment samplings. Conduct hydroacoustic scans. Assist in writing of annual reports required by Federal / State Permits and the TKPOA Waste Discharge Requirements.

Aquatic Invasive Species (AIS) Technician 3 (Full Time/Year Round)

Responsible for assisting the AIS Management Coordinator with day to day activities that support the overall AIS Program goals. This will include assisting and conducting field based projects, collecting field data, maintaining accurate databases, and participating in a proactive information campaign to better inform homeowners and visitors about AIS issues within the Keys Waterways, in accordance with Federal / State Permits, Waste Discharge Requirements (WDR), TKPOA's Integrated Management Plan (IMP) and Non-Point Source Water Quality Plan (NPS).

Summer Aquatic Weed Harvester Operator (Seasonal)

This position is responsible for harvesting aquatic weeds during TKPOA harvesting operations that occur during the summer season in accordance with the Waste Discharge Requirements and TKPOA's Integrated Management Plan. Operate and maintain all required equipment of assigned Harvester. Control and collect harvested weed fragments. Conduct daily, weekly and monthly preventative maintenance of assigned machine.

Summer Aquatic Weed Fragment Control Crew (Seasonal)

This position is responsible for fragment control and collection during TKPOA harvesting operations that occur during the summer season in accordance with the Waste Discharge Requirements and TKPOA's Integrated Management Plan. Operate and maintain all required equipment of a 16-foot Fragment Control Boat. Control / collect harvested weed fragments and collect weed piles from designated areas. Complete duties and support the TKPOA AIS Management Program as required.
